Meeting called to order by Sarah Crowder at 10:00am

Welcome & Introductions: Sarah Crowder (chair)

Treasurer Report: Jacob McMains – *A physical treasurer report was provided to all in attendance and is attached to these minutes.* A list of transaction since the last meeting are as follows (but not limited to):

Old Business

- Admin position filled, intro Andy Berg Sarah had Andy introduce himself to the group and explained some of the upcoming tasks that are outlined per his 30-60-90-day plan (such as a Google for Nonprofit Workspace, website improvements, and communication-related tasks).
- 2024 Conference Update: Jacob McMains
 - The Tiger Hotel in downtown Columbia is the venue for the Conference in which the deposit has been paid. There will be a Thursday night social event at the State Historic Society of Missouri (SHSMO) which the current plan is to hold the awards banquet and silent auction there that evening. The Ozark Mountain Biscuit Company will donate all of the food for the evening and there will also be a bar, which the hope is to have it sponsored to an extent. SHSMO will be looking through their archives to see if they can create a "forestry exhibit" for us.

- Currently working on developing the program. The Committee would like to send out a save the date but would like some more content prior to (such as the keynote speaker and/or other activities).
- Forest ReLeaf agreed to handle registration in exchange for a booth. Eventbrite will be the platform used for registration.
- Sponsorship levels, exhibitor, and registration costs need to be worked out. It was suggested that registration costs may need to be bumped a bit compared to prior years. Also need to consider other registration levels for students, Tree Board Members, etc.
- Dates, a lodging link, and other resources will need to be added onto the website.
- Some of the "bigger name" speakers have been reached out to so far (which may help determine registration costs).
- Considering a pre-conference workshop focused on technology sonic tomography, smart inventory (which the equipment may be in the area), battery chainsaws, drones, etc.
- There are 62 rooms for that Wednesday night and 62 rooms for that Thursday night at the Tiger Hotel. We need to determine if Tuesday night rooms will be necessary if there is going to be a pre-conference workshop.
- Jacob listed off other potential speakers/topics. He suggested to go back to your local groups to see if there are any good candidates for a lightning round, showcasing what it is we do (new projects and other items).
- We would like to encourage folks to attend the Thursday evening social (via marketing the arbor award of excellence, etc.).
- Hank Steltzer is to do a tour on the quad (campus).
- We need to consider rolling out the scholarship program for registrants. The latest scholarship is to be located and considered for this idea.
- Official registration rolled out before Memorial Day.

Committee Reports

- Communications Committee: Meridith Perkins, Brett O'Brien, Jacob McMains
 - Excitement was expressed having Andy on board and Meridith thanked the other members for their work in the process of hiring Andy as Administrator.
 - They will plan a meeting in May to go over some expectations with Andy and discuss Constant Contact and the website

- Forest ReLeaf: Meridith Perkins
 - The CommuniTree applications are open until the end of April. They are shipping a truckload to KC this spring, though statewide shipping is typically done in the fall (there is opportunity for fall delivery for 2024). A 50 tree minimum is preferred for shipping. There are many Arbor Day outreach events in the St. Louis region currently happening. The nursery in Creve Coeur Park has expanded to accommodate another 2,000 #15 trees for their priority ReLeaf projects (for underserved, low income, disaster stricken, etc.)

 - The current Director is retiring and they are in search for a new one few internal people are interested so they have opened it up externally. The current Director will be in place through July. Tree City, Tree Campus, and Tree Line applications are coming in, which there are fewer than last year.

Region Reports & Volunteer Hours – Region Representatives

- Kansas City: Chuck Conner, Sarah Crowder The Heartland Tree Alliance is having their Tree Keepers course in 2 weeks. Chuck explained how dry it is in their region and the concerns for tree longevity. Bridging the Gap has positions available this spring and summer. They just gave away 2,000 #3 trees through the Arbor Day Canopy Cover program, which KC funded. It's a 3-year planting initiative with a million-dollar budget.
- Northwest: Ron Lumb Timothy Wolf is the new forester who will be a good asset. He will contact Ron.
- **Central**: Brett O'Brien, Jacob McMains The Conference Committee is meeting monthly and will meet bimonthly starting in May.

- East Central/St. Louis: Joe Oelke Started the 2025 Conference planning. The tentative dates are September 24-26, 2025 (with a pre-conference workshop on September 23).
